- **GIRLS TOURNAMENT:**
  - **An Entry Fee of \$350 is due before the tournament begins, \$400 day of or after the tournament (adjusted rates for less than a full team).**
  - *\*wrestlers beyond 12/team will be assessed a \$25/per extra wrestler.*
- **First 64 entries (boy's teams) returned on time are only guaranteed entries**

If either school fails to carry out this contract, the school that breaches the contract is subject to penalties as directed by the rules and regulations of the IHSAA.
